Countdown to Implementation

This October, the VIPIR team is holding a communications launch to raise industry awareness of the project and what must be done in preparation of implementation. This launch will not only unveil VIPIR's new name and logo, but will further establish elements of two-way communications with stakeholders.

The first communication changes being publicly released are a revamped newsletter and web site. In response to stakeholder input, the newsletter will focus on providing more details for industry registry users. Batch Specs to be Released

In October 2001, the VIPIR project team will make batch interface specifications available to industry and software vendors.

Releasing these specifications at this stage gives industry and vendors the time they need to develop and test their batch interfaces before the registry is implemented in October 2002. Industry and the software vendors were provided an opportunity to review and comment on the *System Interface Design Principles and Standards* documents this August.

Comments from this review will be used in the final preparations of the specifications. In addition to this, a meeting between the VIPIR team and vendors is being organized in conjunction with the release of the specifications.

The release of the batch interface specifications is another fast approaching milestone that will be met by the VIPIR project team. INDUSTRY TALKS, VIPIR LISTENS

VIPIR is committed to seeking input from stakeholders throughout all phases of the project. A key element of this will be four surveys to gauge the awareness, attitudes, understanding, and readiness of stakeholders for VIPIR.

In preparation for VIPIR's first information survey, a focus group was organized in early July. On the whole, comments from large, medium and small producers were positive. Here are answers to some of the questions asked by the focus group.

OPEN FOR BUSINESS

- **Q** Will VIPIR be operated during the same business hours as Government?
- A- No. Once the registry has been implemented, access to the system will not be restricted to current Ministry business hours. It is anticipated that access to the registry will be at least 16 hours a day, seven days a week except for scheduled maintenance windows.

Once the governance model is established and service level agreements created, the registry hours of availability will be published. In all likelihood, the registry will accept data inputs and process requests submitted by batch at anytime and if necessary hold the completion of the request or process until it can be completed. Some processes that require approval or action by another party may be handled on the next business day.

Further information will be available once registry and governance issues have been finalized.

VIPIR'S GOT A DATE TO MEET

- Q Will VIPIR meet its October 2002 implementation date and is the project on budget?
- A The top concern of the VIPIR team is quality. The database must work for stakeholders. The current project plan still shows VIPIR being implemented on time. The project team, and ministry, are committed to an October 2002 implementation date.

With respect to budget, current to date expenditures and future cost projections indicate that VIPIR will be completed under budget.

GEARING UP FOR TRAINING

- **Q** Will there be on-site training for the VIPIR system?
- A Currently, training Coordinator Dan Magnan is reviewing all options on how to best provide training for the large and diverse group of stakeholders who will be using VIPIR. Additionally, John Nursall has just been hired (see page 4) to work full time on how to best offer on-line training and help to stakeholders.

Industry has committed to pay for the training involved for VIPIR. Industry is also reviewing the most effective way to offer training and how to cover the cost of training so many people.

EUB DATA CLEAN-UP

(The VIPIR team received many queries about the EUB Data Cleanup effort. This is their response to those queries)

The Volumetric and Infrastructure Petroleum Information Registry (VIPIR) will be a single, authoritative petroleum data source and the data it houses is considered the "data-of-record" for all stakeholders.

The EUB Data Cleanup Team was formed in November 2000 to ensure data integrity and consistency between the EUB and DOE databases, before VIP IR is implemented on October 2002. This data clean up focuses on Basic Well Data (BWD) and Production/Injection/Disposition (PID) Data for future use as source infrastructure data for VIPIR. This data will also be the source of data for the test environment for industry to use to test prior to the inception of the Registry.

VIPIR is a joint, strategic initiative between Ministry and Industry. To meet the Registry's stated goal of providing **quality data** that meets **all stakeholder** business needs, well information requests have been forwarded to industry. The purpose of these requests is to ensure that only quality infrastructure data is converted to the registry. This should minimize problems at implementation in dealing with the new business practice of rejecting infrastructure change requests, or volumetric data submissions, that do not meet the business rules.

The effort being expended to get well information updated will be of benefit to Industry, DOE and other EUB groups. At the time of conversion of infrastructure data to the Registry, the EUB will "modify" any well that does not meet registry integrity requirements to ensure that all wells are converted and created in the Registry.

After implementation, the EUB will no longer have the ability to make on-line corrections or submit special adjustments on behalf of an operator to move production from one well to another well for production months prior to registry implementation.
