Indian Oil and Gas Canada (IOGC) manages and regulates First Nation oil and gas resources on First Nation lands. As a full member of Petrinex, IOGC has partnered with Petrinex to provide updates and links to new and pertinent information, including the following:

- The [Indian Oil and Gas Act](#) and [Indian Oil and Gas Regulations](#) came into force Aug 1, 2019 and IOGC prepared a detailed [Stakeholder Readiness Guide](#).
- Recently, IOGC posted an [Information Letter on Expanded Royalty Reporting Requirements and Jurisdiction](#) which includes information on the increased time limitation of **10 years** for the keeping of documents related to royalty reporting as well as additional information.
