Audience: AB Industry Users

Purpose:

To advise Alberta industry users of a name change to the Alberta Energy and Minerals report packages available in Petrinex under the Ministry Reporting Menu effective July 4, 2024.

Background:

With the name change of the Department of Energy (DOE) to the Department of Alberta Energy and Minerals (AEM) a change has been made in Petrinex to the package names for existing DOE reports. As of July 4, 2024, this new naming convention is required when downloading these reports online from the Ministry Reports menu or an internal or vendor system. Changes will have to be made to your internal systems if you currently have a process for downloading these report packages.

Note: there is no change to the report names in each package.
