

## **Fuel Gas Purchased from Gas Co-ops Associated with Gas Alberta Inc.**

**Audience:** All Alberta Stakeholders

**Purpose:**

To remind AB users how to correctly report gas purchased from co-ops associated with Gas Alberta Inc.

**Key Principles:**

Historically many operators have purchased fuel gas from gas co-ops associated with Gas Alberta Inc. (Gas Alberta) and reported the gas received from AB Miscellaneous (ABMC) or AB Commercial (ABCO). To reduce, where applicable, the use of ABMC/ABCO for the receipt of gas, operators need to contact Gas Alberta to confirm if the co-op is associated with the Gas Alberta Pipeline AB PL 0004926. If so, Gas Alberta will set up a new meter station (subtype 632) on the pipeline that will show a receipt of gas from the Gas Alberta pipeline, a disposition to the auto-populated facility (i.e. BT, WP, IF etc.) which will then be auto-populated as a receipt at the auto-populated facility.

Note: Effective January 9, 2025, Petrinex will no longer allow the reporting of receipts from ABCO, to align with the Alberta Energy Regulator (AER) definition of the miscellaneous code ABCO in AER Manual 011 (Table 6). See [Tip 384 "Receipts from ABCO \(Commercial\) Not Permitted"](#).

To start the process and request a new meter station set up:

1. Contact Gas Alberta via their email address [info@gasAlberta.com](mailto:info@gasAlberta.com).
2. In the Subject line indicate: "Gas purchased from Co-op" to ensure it is forwarded to the appropriate person.
3. Gas Alberta will require your BA ID and the facility ID that is to be receiving the gas. You are also required to provide a copy of an invoice received from the co-op to confirm the meter station location.
4. Gas Alberta will confirm the co-op is on their list of customers\* and set up the new meter station subtype 632.
5. Gas Alberta will advise you of the meter station ID and give the purchasing operator instructions on when the change will occur and provide instructions on how the monthly volume identification will be handled.
