Saskatchewan Helium Valuation Non-Compliance Errors Billing

Audience:

All SK Helium Producers and Owners

Purpose:

To advise SK users that effective August 8, 2024, Saskatchewan Energy and Resources (SER) will be implementing Helium Valuation Non-Compliance Errors Billing functionality for all errors not corrected by the valuation deadline (including prior period February 2023 to present).

Background:

On March 2, 2023, Petrinex implemented enhancements to include Non-Hydrocarbon Gas Valuation in Saskatchewan effective production month February 2023. The only valid product is Helium. For more information about the functionality, the Petrinex tip can be found here. At that time, Helium Valuation Non-compliance Errors Billing functionality was not included.

Key Principles:

Effective August 8, 2024, Helium Valuation Non-Compliance errors will be assessed for penalty and invoiced for all errors, including prior period (February 2023 to present) not corrected by the Valuation Reporting deadline, which falls on the last working day of each month. To check deadline information, refer to the monthly Saskatchewan Reporting Calendars.

To assist users to determine if there are any outstanding non-compliance errors, a Non-Hydrocarbon Gas Valuation Non-Compliance Report – Warning Report is generated by Petrinex prior to the deadline and is available in the Petrinex inbox. In addition, helium producers and owners can run an on-request version of this report at any time to check their existing noncompliance errors.

The following table shows the types of errors that can be triggered, the associated noncompliance fee and the assessment frequency:
