Purpose:

To inform Industry that effective October 3, 2024, users with "read only" access will have the Petrinex auto-generated warning and final notifications suppressed. This update does not affect the on-demand report request access set up by the BA User Security Administrator (USA).

Background:

Currently <u>all</u> users in Petrinex receive the warning and final report notifications. Based on a request from the Industry Benefits Committee (IBC), these notifications are to only be received by those users with an edit task. This change of suppressing the warning and final report notifications will be staged in order to accommodate the large number of impacted reports.

NOTE: If a user with "Read Only" access would like to continue to receive any of the warning or final report notifications, they should contact their USA to provide the appropriate Edit access.
