**Audience:** All Manitoba Indian Oil & Gas Canada (IOGC) Users

**Purpose:**

To inform Manitoba Industry users that Indian Oil and Gas Canada (IOGC) reporting functionality is now available in Petrinex.

**Overview of Changes:**

**IOGC Reporting Processes**

IOGC now supports Manitoba reporting in Petrinex, aligning with the processes already in place for Alberta and Saskatchewan. These include:

- IOGC Gas Cost Allowance (GCA)
- IOGC Product Pricing
- Royalty/Tax Payer
- Oil Valuation – Royalty/Tax Payer
- Oil Valuation - Purchaser

If you are new to IOGC reporting, we recommend reviewing the Alberta and Saskatchewan reporting processes to prepare for future activity on First Nation (FN) Wells of Interest in Manitoba. To deepen your understanding, complete the comprehensive IOGC Reporting Learning Modules available in the Petrinex Learning Centre. **IOGC User Setup:**

To enable IOGC reporting in Manitoba, your **User Security Administrator (USA)** must:

1. Create a new IOGC Reporting Role
2. Assign the appropriate tasks using the following templates:
  - Petrinex IOGC GCA Edit
  - Petrinex IOGC GCA Read Only
  - Petrinex IOGC Ministry Reporting
  - Petrinex IOGC Product Pricing Edit
  - Petrinex IOGC Product Pricing Read Only
3. Use the **Manage User ID** functionality to assign this role to the relevant BA users.

## **IOGC Extracts:**

Each month, Petrinex sends IOGC a comprehensive extract containing **royalty related data** for all IOGC well events of interest. This extract includes

- FN interest well information
- Well status changes
- Well to facility links
- FN interest (AB), Royalty Tax Attributes (SK/MB)
- Royalty/Tax Payer data
- Volumetrics and Stream Allocations
- Oil Valuation – Royalty/Tax Payer (RTP)
- Oil Valuation – Purchaser
- IOGC Product Pricing

This extract contains both current and prior periods where data has changed. To ensure completeness, industry must submit all required data on time.

Additionally, IOGC receives an **annual extract** from Petrinex of all **GCA1, GCA2 and GCA3 data** after the May 31<sup>st</sup> IOGC GCA deadline.
