Audience: All Stakeholders

Purpose: This tip describes the Petrinex “Volumetric Security Blanket” to provide an understanding as to what data is available to non-operators within Petrinex for all jurisdictions (BC, AB, SK, MB) and under the public data access web pages which is currently only applicable to AB and SK.

Key Messages:

The Petrinex volumetric security blanket ensures that commercially sensitive data is only available to appropriate parties. The security blanket applies to all jurisdictions for volumetric query and report functions and is also applicable to the public data access web page for Alberta and Saskatchewan. There is currently no public data access for British Columbia or Manitoba. Please note that the volumetric security blanket does not affect the business rules regarding experimental, experimental/confidential, or confidential facilities/wells.

Petrinex security regarding access to gross volumetric data associated with **non-experimental & non-confidential** facilities/wells has two components:

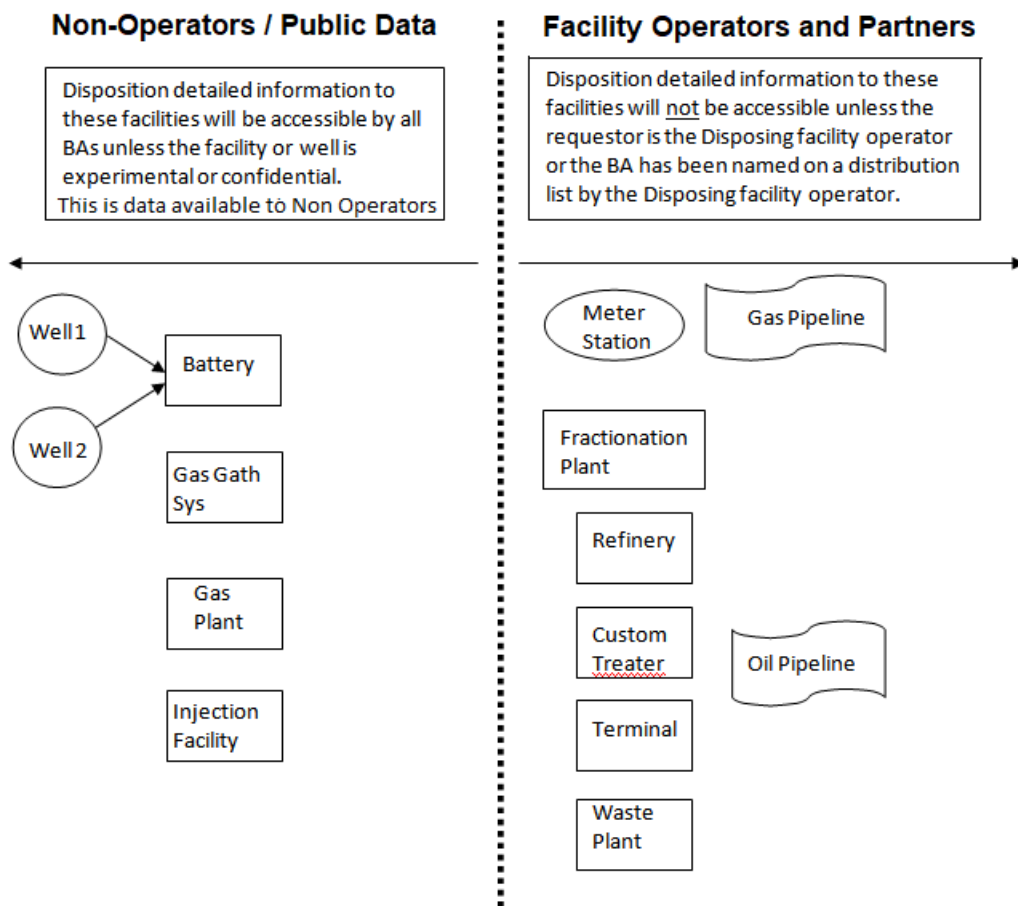
1. Unless the requestor of a facility’s gross volumetric data is the **operator** of that facility, **“All”** access to a facility’s volumetric information is restricted for the following facility sub-types:

- Custom Treater (CT)
- Terminals (TM)
- Meter Station (MS)
- Refinery/Upgrader (RF)
- Pipeline (PL)
- Gas Plant (GP- Subtype 407)
 - Only those facilities with a Specialized Status “Fractionation Plant”

Waste Plant (WP)
Oil Sands Processing Plant (OS) (AB only)

- Non-operators are not able to view detailed “Disposition” information to a CT, TM, MS, RF, PL, GP (Subtype 407), WP or OS.

For example: Dispositions to a non-confidential Battery (BT), Gas Gathering System (GS) or regular Gas Plant (GP not Subtype 407) will display the from/to data including the volume and the facility the product was disposed to. However: dispositions to a facility under the security blanket, for example from/to a Terminal (TM) or Pipeline (PL) will not be displayed individually. The total disposition volume for the product will be available but no details regarding the from/to facility(s) will be displayed.
