Changes to Petrinex Data/Functionality as a result of the Well and Facility Infrastructure Module (IRIS)

Purpose: To advise Saskatchewan Petrinex users that the

Ministry of Economy (ECON) is removing some data elements/functionality in Petrinex and adding others. These changes will be reflected in Petrinex when the

Well and Facility Infrastructure Module is

implemented within ECON's new Industry self-serve Integrated Resource Information System (IRIS) on

November 19, 2015.

Background: As part of the development of IRIS, ECON adopted a

number of changes to our data model to be more in line with Professional Petroleum Data Management (PPDM) standards, including adoption of the "What is

a Well" terminology developed by PPDM.

As a result of that decision some of the data elements

on Petrinex no longer align with the new model.

Therefore, a number of changes are required to some of the data elements and functionality in Petrinex.

Key Messages: In an effort to simplify the government's data

conversion efforts between IRIS and Petrinex, and to account for the terminology changes required by Saskatchewan's adoption of PPDM's WIAW, the following data/functionality will be removed from

Petrinex effective November 5, 2015:

Royalty Tax Attributes

- Stream Name for well events (changed from the well name to the Canadian Well Identifier (CWI))
- Royalty Status (This is a temporary change which will become effective on November 5, 2015. At some time in the near future, ECON plans to consider alternative

- methods to providing access to royalty status information through Petrinex)
- Royalty links related to projects (this change is related to the removal of royalty status information).

**Note: All other Royalty Tax Attributes, including mineral ownership information and unit links, will continue to be available on Petrinex. A complete summary of all royalty related information, including royalty status, will be viewable in IRIS.

The following data/functionality will be added to Petrinex effective November 5, 2015:

Well Fluid Types

- WASTE
- NITROGEN
- BRINE
- HELIUM
- OXYGEN
- SOLVENT

Well Mode Types

- TESTING
- MINSUSPEND
- CANCELLED

Since royalty status information will not be available in Petrinex after November 4, 2015, and will also not be available in IRIS until November 19, 2015, ECON is asking that inquiries related to updates on royalty status of a well or unit during that period be directed to ER Support.
