Audience: All Stakeholders.

Purpose: This alert outlines the implementation of a series of enhanced and new DOE Oil business Unit reports available via the Registry.

As these enhanced and new reports are being phased in, this Alert will also inform users when these reports will be made available.

Background: Over the next few months the DOE's Oil Business Unit will be implementing a series of new reports that will provide additional well and royalty related data through the Registry.

These report enhancements come after consultation between the DOE and Industry representatives in response to the DOE Oil Royalty Benefits Sub-Committee recommendations on ways to improve the content, format and timeliness of reporting and to make available comprehensive lists of wells in various programs, etc.

Recommendations include:

- Assisting Industry in maintaining the most accurate information on Royalty Programs and Certification, including the attempt to make available the most current data at all times.



- To work with Industry to ensure that critical data elements are provided in a timely fashion, as much as possible.
- To work with Industry to investigate the various methods of updating and providing data (mainly via the Petroleum Registry).

The enhancements also include providing a number of existing reports in CSV format.

Key Principles:

The following reports are now provided in CSV format:

DOE - Crude Oil Crown Royalty Statements

- First available in the Registry in CSV format on June 29th, 2005.

DOE Oil – Royalty Confirmation Report

- First Available in the Registry in CSV format on July 22nd, 2005.

Statements of Royalty Adjustments and Transportation Allowances

- First available in the Registry in CSV format on July 25th, 2005.

APMC/Operator/DOE Reconciliation Report

- First available in the Registry in CSV format on August 3rd, 2005.

The following items are also available in the Registry -

Certification Statements

- First available in the Registry in TXT, CSV and PDF format on August 2, 2005

- First Available in the Registry in TXT and CSV format on July 18, 2005.
